Online Tenders are invited under two-bid system from Tenderer who owns Land or holding land under registered lease deed for a minimum period of 13 years with the permission to construct godown or willing to acquire land by way of ownership /registered lease deed within 120 days from the date of acceptance of tender for construction of godowns for FCI Storage Requirements to be managed and supervised by BSWC for a guaranteed lease of Ten years on Build, Own & Operate/lease basis for 2.25 Lakhs MT capacity for storage of food grains at the following locations mentioned below:

- Tenderers are required to upload all the scanned document serially so that any particular document could be located on the basis of SI. No. / Page No. All documents be uploaded in Pdf, MS Office (Compatibility Mode), JPEG, ZIP Format otherwise any claim by the tenderer shall not be entertained.

- 15. The tenderer shall submit separate tender for each location and site.
- 16. Apart from Cost of BOQ of Rs. 5500/- Bid processing Fee of Rs. 1180/- to be paid through online mode [i.e. NEFT/RTGS.] by Tenderer
- 17. If the date of opening of the tender is declared as holiday, the tender will be opened on the next working day at the same time and venue.
- 18. Incomplete offer/offers not conforming strictly in the manner prescribed/offer not submitted on prescribed Tender Form **or late/delayed** tender shall not be considered and shall be summarily rejected.
- 19. Conditional Tenders will be summarily rejected and EMD will be forfeited.
- 20. The location of the land specified in the Tender cannot be changed at any stage under any circumstances.

- 26. The offers shall remain open for acceptance for 120 days from the date of opening of the Technical Bid. However,
  BSWC reserves the right to extend this period by another 45 days at its discretion, which shall be binding on the
  Tenderer. Thereafter, this period may be further be extended by the parties on mutual consent. Any Tenderer not
  keeping the offers open for the prescribed period shall be summarily rejected and his EMD shall be forfeited.
- 27. The Tender must be accompanied by an EMD of Rs 20.00 Per MT (Rupees two lakks only) should be deposited through NEFT/RTGS or other Electronic means. Copy of Bank acknowledgement receipt with UTR no. duly signed and stamped issued by remitting bank is to be uploaded along with Technical Bid.
- 28. In case the tenderer does not own land or hold it on registered lease but intends to acquire the same by way of ownership/registered lease within 120 days from the date of acceptance letter he shall also furnish in addition to aforesaid EMD, a Supplementary Guarantee in the form of Bank Guarantee @ Rs 100.00 (Rupees One hundred Only)per MT issued by any Nationalised Bank and valid for a minimum period of six months from the date of submission of Tender.
  - 29. Tenders not accompanied by prescribed cost of tender documents, Earnest Money and supplementary guarantee (if applicable) will be summarily rejected.
  - 30. The earnest money (along with Supplementary Bank Guarantee, if applicable) would be refundable to unsuccessful Tenderer on finalization of the tender and shall carry no interest whatsoever.
  - 31. Incomplete offer/offers not conforming strictly in the manner prescribed /offer not submitted on prescribed Tender Form **or late/delayed** tender shall not be considered and shall be summarily rejected.
  - 32. The location of the land specified in the Tender cannot be changed at any stage under any circumstances. The Khasra/Khata no./Dag no along with land boundary demarcation must be mentioned in technical evaluation sheet. The tenderer has to enclose with the tender a detailed site and lay out plan indicating the location of proposed structure and also showing the approach to main road.
  - 33. The tenderer shall at his cost construct godown at the specified locations as per Engineering and other godown specification / condition attached to the schedule of this tender.

- 39. The bidder(s) will have to produce all or any documents in original whenever asked by the corporation BSWC reserves the right to seek any relevant documents (directly or indirectly) any time.
- 40. At places where there is a full rake Railway goods shed, the site should preferably be within 8 KM of goods shed. Where no full rake railway goods shed exists the site should preferably be within a radius of 8 Kms. of the municipal limits of such places or 15 Kms. from zero point of such location. Wherever 25,000 MT and above capacity is required, it should preferably have the provision for private railway siding. The land should preferably be on National or State Highway. They should offer only such land/site which has access through all-weather black topped or RCC/CC road of minimum width of 22 feet except in hilly regions. Brick paved road or gravel road is not acceptable. The road leading to the godown should be free from any kind of traffic restriction for truck movement. Distance criteria of within 8 KMs. radius from full rake railways goods shed does not apply to godowns with a railway siding. The possession of godown would preferably be taken when an all-weather road is built from link Road to the godown.

# 41. <u>LAND REQUIREMENT</u> <u>FOR CONVENTIONAL</u> <u>TYPE STORAGE</u> <u>GODOWNS (IN IDEAL SHAPE):</u>

- a) First 5,000 M.T Capacity = 2.0 Acres.(approx)
- b) Further 1.7 acres additional land will be required for an increase

of 5,000 MT capacity godown each.

The plot of land shall be as far as possible rectangular shaped. In case of railway siding godowns, the length of the plot should be enough to accommodate full rake facility in single placement. The above land requirements are Minimum and it may vary depending upon the shape and topography of the land.
